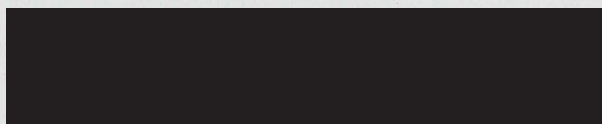


CERTIFICATE

The company



is granted authorisation according to STANDARD 100 by OEKO-TEX® to use the STANDARD 100 by OEKO-TEX® mark, based on our test report 21.0.50 [REDACTED]



for the following articles:

White, reactive, disperse dyed knitted fabric produced from organic CO, organic CO/EL, organic CO/CLY/EL, organic CO/CLY, organic CO/CV, organic CO/CMD, organic CO/CMD/EL, organic CO/CMD/PES, organic CO/PES (also melange, brushed), organic CO/PES/EL, white, reactive dyed woven fabric produced from organic CO; reactive printed knitted fabric produced from organic CO, organic CO/EL, organic CO/CLY, organic CO/CMD, organic CO/CLY/EL, organic CO/CV, organic CO/PES (also melange); reactive, pigment printed woven fabric produced from organic CO; white, reactive, disperse dyed, reactive printed knitted terry fabric produced from organic CO/PES; pigment and matt white printed knitted fabric produced from organic CO, organic CO/EL, organic CO/CV, organic CO/CMD/EL, organic CO/CLY/EL, organic CO/PES (also melange); digital printed knitted fabric (reactive dyes) produced from organic CO, organic CO/EL, organic CO/CLY/EL, organic CO/CMD, organic CO/CMD/EL, organic CO/PES/EL (also brushed), organic CO/PES (also melange) and woven fabric produced from organic CO; glitter printed knitted fabric in silver and gold produced from organic CO, organic CO/EL; yarn dyed and melange knitted fabric produced from organic CO, PES, CV (bamboo) mixtures among each other with/without elastane as well as all PES part also recycled from PET bottles, all organic cotton (GMO not detectable); produced by using materials certified according to STANDARD 100 by OEKO-TEX®.

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 6, **product class I** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 6 for baby articles.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
